ANNUAL HOUSEHOLD HAZARDOUS WASTE COLLECTION DAY

The Franklin County Solid Waste District is holding its annual household hazardous waste collection on Saturday, September 23rd at GCC Main Campus and Orange Transfer Station.

Residents and businesses must pre-register between August 17 and September 15. During that time, online registration will be open: <u>www.franklincountywastedistrict.org/</u> <u>hazwasteday.html</u>. Paper registration forms will be available at participating town offices, transfer stations, and in ads in the Greenfield Recorder.

The collection is free for residents of most member towns (see website for list). Businesses must pay for disposal costs. For business registration information, call (413) 772-2438.

This collection provides an opportunity to dispose of hazardous items that should not be put in the trash, such as leftover oil-based paints, stains, thinners, household cleaners, pesticides, herbicides, pool chemicals, motor oil, antifreeze, automobile batteries, and other household chemicals. For a complete list of acceptable items, see: www.franklincountywastedistrict.org/hazwasteday.html.

Mercury-containing products such as thermometers, thermostats and compact fluorescent bulbs (CFLs) should never be disposed of in the trash. At the 2017 Hazardous Waste Collection Event, only mercury-containing items such as thermostats and thermometers will be accepted; fluorescent bulbs will not be accepted at this collection. CFLs and other fluorescent bulbs are accepted at all municipal transfer stations. In addition, fluorescent light bulbs are accepted at Lowe's Stores (all types of fluorescents), and Home Depot (CFLs only).

While looking for some place different to go before Theater at the Mount, we stumbled upon The Tavern on Central. Menu sounded good so we gave it a shot. They only take reservations for more than 6 so we were lucky, we have 7. The place was packed but we got a table way in the back which was nicer because it was quieter. Acoustics are not that great because of the open and exposed ceilings.

But the food was excellent. Everyone raved about their meals. I had the Baked Haddock with a huge piece of haddock served floating on Sweet Corn Cream Sauce with Bacon and Fingerling Potatoes. It was delicious. \$10 and I couldn't finish the sauce mixture because it was so rich, but so flavorful. Others had the Pan Seared Salmon, with asparagus and wild mushroom risotto, and said it was excellent and only \$12. My niece had the Burger and said it was one of the best burgers and the French fries are awesome. All the food passing by looked fabulous and we all want to return.

It's not a place to go for a 'quiet' evening because it is very popular with the younger crowd and they are there for a good time. Lots of laughter and loud talking but you can't beat the food. Service was excellent too. I highly recommend it for either lunch or dinner. Bon Appetite.

TRINITARIAN CONGREGATIONAL CHURCH of WARWICK

August 2017

Dear Friends,

Last month, I talked about attending a joint meeting of the southern New England Conferences of the UCC, held in Hartford, CT. This month, I am recently back from a five day, biennial Synod (convention) of the national UCC, held this year in Baltimore, MD. Much of what I reported about the meeting in Hartford could be said about this convention in Baltimore; words were carefully chosen to enhance unity without stifling disagreement, care was taken to hear from all sides of an issue, those whose voices rarely get heard were given time and a place on the stage to express their hopes and concerns.

I hope you have all, at one time or another, had the experience of being with a very large group of people who all have a similar sense of purpose. It is inspiring, invigorating and energizing. The gathering in Baltimore, for me, was even more inspiring because of the diversity of the people. Large church gatherings in New England, that I have attended, have been largely white; white skinned and white haired. This convention was a wonderfully diverse event. There were nearly as many people of color as Euro-Americans, a large contingent of young people, a wide spectrum of sexual orientations and a diversity of worship styles. This gave a depth to the public and private conversations, an intensity to the hearings and workshops and an amazing richness to the business meetings and the worship events.

The music was amazing. The variety ranged from "Bluegrass Gospel" to "Urban Gospel", from jazz to classical, instrumental to acapella, choral to solo. It was all powerful and first rate. And the speakers and preachers were also inspiring and diverse in style and content. There were preachers of what I would call, revival style exhortation, with great animation and audience response, and preachers of a more contemplative and introspective nature; all fully biblically based. (If only our political and governmental dialogs and actions could be as broad based and civil.)

The business before the Synod was also diverse. There were resolutions dealing with Climate Change, rights of children living under military occupation, issues of adult survivors of childhood abuse and neglect, end-of-life choices and rights, and many others. We usually began our days with breakfast meetings at 6:30 and often ended well into the night. There were intense conversations, but, for the most part, they were dialogs, meant to inform and build understanding and consensus, rather than debates with winners and losers.

Part of the business before us was the election of officers of the national church and the election of an Executive Minister of Justice and Witness Ministries of the national church. Rev Traci Blackmon was elected by a 97% majority. She is a young, articulate, vibrant woman of color, who was instrumental in turning the crisis in Ferguson, MO from violent confrontation into constructive dialog and change. It is an honor for the UCC to have such a leader on our national staff.

The two years between Synods is given a focus theme and for this coming interim period it is "Three Great Loves; a just world for all". The three great loves are: Love of Neighbor, Love of Children, and Love of Creation. Each day there was an event that tied the three together and one of those events was the presentation of the first "Movement Makers Award" to the youth of the Standing Rock Water Protectors. Ten youth from the Standing Rock reservation talked about the effort to protect their peoples' water source, the sacredness of the earth and the gathering of people from around the world and across religious backgrounds to oppose the route of the pipeline that is a potential hazard. All three loves are interconnected. Protecting God's Creation from exploitation and degradation is of immense value to the children of the world and must be addressed by all; we are more interdependent than independent...

I. Call to Order

Chair Pruyne called the meeting to order at 6:00 p.m. in the Town Hall.

II. Minutes

Magi MOVED to approve the minutes of May 22, 2017 as printed. Erviti SECONDED. Motion CARRIED 3-0-0.

III.Presentations and Discussions

- 1. Capital Planning and Finance Committee —Young said that no one has responded to his notice asking for volunteers to serve on the Finance Committee. He noted that John Gagliani disagrees with the idea of the Finance Committee and Capital Planning Committee being one in the same. Young said that he and Gagliani will pursue capital planning. Moderator David Koester said that he may know of someone interested in serving on the Finance Committee and is willing to appoint that person once he confirms their interest.
- 2. Highway Department —Highway Superintendent Larry Delaney said that he feels the estimate from Collins Engineers for completion of the Gale Road bridge project is way too high. He explained that the \$600,000.00 estimate does not include design, permitting and construction administration, which would add \$145,022.82 to the final cost. Delaney said that Collins had responded to the fact that the estimate exceeds the \$500,000.00 grant by telling him to ask for more money. He said that there is a second design company which has suggested tying in the bridge project with a MassWorks grant, and that he hopes to hear back from this firm in the near future.

Erviti asked if we can do the bridge work ourselves. Delaney explained that MassDOT created the small bridge program and has taken control of all small bridges and all their specifications must be met. He said some things may be done by our Highway crew to save on overall costs.

Magi MOVED to explore other options for the Gale Road bridge. Erviti SECONDED. Motion CARRIED 3-0-0.

The Chapter 90 balance was discussed. Delaney said that as of today our balance was \$373,716.69 which did not include the FY 18 award of \$224,061.00.

Young asked about priorities. Delaney said that crack sealing on various roads including Hastings Heights Road and Flower Hill Road could be done by the Highway crew, and that they could rent a crack sealing machine to save on the cost. Delaney noted that another 3 miles of Northfield Road needs to be worked on in sections as funding permits, and that this could be a good candidate for a MassWorks grant.

Delaney was asked to come before the Board again and present a list of the top five projects for the Highway Department as well as other less important priorities.

Erviti brought up the subject of salt use by saying that he has heard that Wendell uses a 4-to-1 mix. Delaney said that he will verify the mix used by the Wendell Highway Department. Use of 3/8-inch traprock was discussed. Delaney explained that it is used along with sand on the dirt roads in town but not the paved roads. He expressed concern for the potential damage to windshield of vehicles traveling the paved roads because of the increased speed at which people drive on those roads. Delaney said that the traprock stays on the road after the snow melts and tires could kick it up, potentially causing damage to houses close to the road and could affect pedestrians and those walking their dogs.

- **3.** Selectboard Reports —Pruyne said that someone who has lived in Town for about 35 years told him that once in the past a person pulled out a Bowie knife and plunged it into the table in front of the Selectmen. Young confirmed that this did in fact occur.
- 4. Coordinator Report —Young said that the air source heat pump installation was going very well, and that the next step is for the electrician to come in. He said that the final cell tower 900 MHz sector has been upgraded, and even though it is not yet fully optimized speeds are showing solid improvements. Young said that he has checked out Tim Gray's references and still has to look into those of Noah Horton and Matthew Woollaven. He explained that because Transfer Station Attendant George Roaf is not interested in working on Wednesdays this summer, most likely bulky waste will not be accepted on those days. Young ended his report by saying that he has two qualified volunteers for Caretaker of the Clock: Clyde Perkins, Jr. and John Gagliani.
- 5. Public Comment—Ruggiero asked about the five window air conditioners that were mentioned in the Coordinator Report. Young said that the PVRSD Superintendent did not want the air conditioners which he had hoped to have declared as surplus property and then given to PVRSD for the administrative offices. Ruggiero suggested storing the units at the Fire Department if someone, especially an elderly resident, with a health issue needs an air conditioner during a heat wave. Erviti said that this could potentially present a liability issue if a Town department was involved. Ruggiero volunteered to put in the units himself as a private citizen rather than a Fire Department member if needed. Young pointed out that the Town Hall

is offered as a cooling station during heat waves. Ruggiero then suggested offering the units at a low price, first-come-first-served.

- 6. New and Other Business Unanticipated at Time of Meeting Posting —None.
- **7. Pole Hearing**—At 7 p.m. Chair Pruyne declared the Warwick Broadband Service Pole Hearing open.

Walter Farley asked if the pole on White Road would be located on the north or south side of the road. Young said that the pole will be across and down the road from the Farley house and noted that placement of all twelve poles was done in an unobtrusive manner so as not to obstruct anyone's view.

Young went through the list of all 12 proposed pole placements, described the location of each pole and asked for any questions after explaining each pole location. Kevin Alden had concerns about how close the poles would be to the edge of the road. Young said that most would be 4 feet back from the road and none would be as close as the utility companies favor placing their poles. Young assured everyone that no poles would be placed on logging roads or snowmobile trails.

Dan Dibble asked if any tree cutting might be necessary. Young explained that tree cutting would be a subsequent event if needed and that a tree hearing must precede any cutting. He noted that Westfield Gas & Electric has been contracted for installation of the poles. Young said that the desired timeframe for completion of pole and equipment installation was within the next 6 weeks. He noted that provisional changes will be upgraded further in the future by building while in business and maintaining customer connections. Young said that the desired speed was 25 megs for downloads and 3 megs for uploads. He said that he sees all build out to take about one year and be good for around seven years. When asked about impact on cell service, Young said that stronger internet may strengthen our pitch to cell providers because the 60-foot poles would already be in place and in use.

Pruyne closed the hearing at 7:28 p.m.

I. Call to Order

Chair Pruyne called the meeting to order at 3:05 p.m. in the Town Hall.

This meeting had been posted as a Joint Meeting of the Selectboard and Finance Committee.

II. Presentations and Discussions

1. One-Day Beer and Wine License—Young said that the Church (TCC) asked that the Moore's Pond Beach Committee serve beer and wine at an event to be held in Town Hall on Saturday, June 24th. He noted that the proceeds of the sale of beer and wine will go to the Beach Committee. Young reminded the Board that a license must be granted to a person or persons and not to a Town Committee and that the proceeds must benefit the Town. He said that we have liability insurance because the event is being held in a Town building.

Magi MOVED to issue a one-day beer and wine license to Matt and Kathy Connelly on behalf of the Moore's Pond Beach Committee for June 24, 2017 TCC event at Town Hall. Pruyne SECONDED. Motion CARRIED 2-0-0.

2. School Committee—Young said that he wanted to discuss the idea of having a meeting between the Selectboard and Warwick School Committee members. He explained that at the most recent PVRSD School Committee meeting someone had suggested that each School Committee meet with its own Selectboard to discuss an additional appropriation from each town for the school lunch budget deficit. Both Pruyne and Magi favored meeting with our School Committee members Martha Morse, Sue O'Reilly McRae and David Young at a future date, most likely in the month of July.

Bill Foote arrived at 3:15 p.m. and a quorum of the Finance Committee was achieved.

3. New and Other Business Unanticipated at Time of Meeting Posting—The draft agenda for the Selectboard's June 19, 2017 meeting was reviewed. One item was removed as it was handled at this meeting. The Concept of Community Compact was discussed; Young said that he would do more research on the matter.

Young said that the West Brookfield solar farm was being tested and that the Selectboard had been invited to the solar farm on Wednesday, June 21st for a demonstration.

I. Call to Order

Chair Pruyne called the meeting to order at 6:00 p.m. in the Town Hall.

Pruyne noted the recent passing of Raymond Wirth of Athol Road.

II. Minutes

Magi MOVED to approve the minutes of June 5, 2017 as printed. Pruyne SECONDED. Motion CARRIED 3-0-0.

III.Presentations and Discussions

- 1. Capital Planning and Finance Committee Young said that there was still not much interest in this and no one has volunteered to serve on the Finance Committee. Magi suggested Jim Toth as a possible member for the Finance Committee if he chooses to move back to town.
- 2. FY 17 Forest Committee Revolving Account —Young explained that funds cannot be expended from a revolving account in excess of the amount voted at Annual Town Meeting unless the Board votes to increase the amount. Revolving accounts cannot go into deficit spending, and this increase would allow for the supervising forester fee to be paid.

Magi MOVED to authorize the Forest Committee Revolving Account be increased from \$2,000.00 to \$2,100.00. Erviti SECONDED. Motion CARRIED 3-0-0.

3. Community Compact in Support of HEART Committee — Young said as Town Coordinator he felt it couldn't hurt to go forward with the application for a \$25,000.00 Community Compact grant. He favored being able to steer the consultant's work to ensure that charter schools be looked at as an option. He noted that this grant can be used for things other than the HEART Committee. Magi inquired about the community strategy / priority list as a possible way to identify other viable options. Young said that as this could also be a part of capital planning the list should be updated soon anyway. Erviti said that there may be some merit to the letter from School Committee and HEART Committee member Sue O'Reilly-McRae. Pruyne favored an outside study, as did Erviti and Magi. Erviti noted that someone impartial can look at a situation and evaluate it from a fresh perspective. Former School Committee member David Shoemaker said that an evaluation from the outside is good because things are not sustainable long term. Pruyne said that an outside evaluation might be an opportunity to present the teachers with an instrument that might cause them to acknowledge the limits of the current situation. Erviti stressed that if grant funds are awarded, someone from the outside and not someone internal should be hired as a consultant.

Magi MOVED to ask the HEART Committee to go forward with the Community Compact Grant application with the contingency that they state the best practice and the vast majority of the funds be used for outside consultants. Erviti SECONDED. Motion CARRIED 3-0-0.

4. Warwick Police Department Report —Police Chief David Shoemaker said that the Northfield Road paving went very well and that there were no problems with the detour. He said that National Grid is having tree trimming done throughout town. The Chief said that the Recreation Committee did a good job with Warwick Fun Days at the School on June 23rd. He expressed appreciation to the Pioneer Valley Junior Women's League in Orange for the donation of bicycle helmets.

The Chief said that there have been a couple of recent incidents of tire dumping in areas that suggest the perpetrator is familiar with the Town. He asked that the public be vigilant and report any suspicious activity immediately. Larry Delaney said that the Highway Crew will remove the tires this week.

The Chief noted that Brian Gale retired as Sergeant about a year ago and asked for no fanfare. He asked that the Town now do something to recognize all of Gale's many contributions to the Town, perhaps with a plaque or citation from the State Legislature. The Chief referred to gale as "the epitome of public service".

Magi MOVED to recognize the accomplishments of Brian Gale. Erviti SECONDED. Motion CARRIED 3-0-0.

The Chief said that Officer John Stewart II is close to indispensable to the Police Department and wanted to promote him to the rank of Sergeant.

Magi MOVED to appoint John Stewart II Sergeant in the Warwick Police Department effective July 1, 2017. Pruyne SECONDED. Motion CARRIED 2-0-0. *Erviti recused himself from this vote*.

5. Annual Selectboard Appointments—The list of FY 18 Selectboard Appointments was divided into two sections: Police Department and Emergency Management Director, and the remaining positions for appointment. As Selectboard member James Erviti is a Special Police Officer and the Emergency Management Director, he recused himself from the vote for these positions.

Magi MOVED the FY 18 slate of appointments for the Police Department and Emergency Management Director. Pruyne SECONDED. Motion CARRIED 2-0-0. *Erviti recused himself from this vote*.

Erviti MOVED the FY 18 slate of appointments effective July 1, 2017. Magi SECONDED. Motion CARRIED 3-0-0.

The full list of appointment appears at the conclusion of these minutes.

6. Fire Department Report — Fire Chief Ron Gates said that the FD roster is up to fifteen, and noted he has appointed Joe Larson as a Lieutenant.

The Chief then announced that he has found a brush/rescue vehicle owned by Somers, CT. He passed around photographs of the vehicle and said that he and Mike Mankowsky checked the vehicle out and road tested it on June 24th. The Chief noted that the 2006 vehicle has 41,000 miles, is in phenomenal shape and will meet the department's needs perfectly. The purchase price is \$35,000.00. He said that it will need new tires and bumper, which likely will cost no more than \$5,000.00 and could be less than that. Young noted that conceivably the purchase could be on the next warrant.

7. Grant Reports—Highway Superintendent Larry Delaney said that to save costs on the Gale Road bridge project he is going forward with getting one telephone pole moved from one side of the road to the other. He said about eight or ten trees have been marked for cutting to allow for clearance for the wires, and that the Tree Warden will be scheduling a tree hearing. Delaney said that he is also working on a notice of intent for the Conservation Commission to remove stringers from the bridge.

Young said that the bicycle racks have arrived and will be installed between the Town Hall and Historical Society buildings. He noted that the racks resemble horse hitching rails.

Young spoke about the Broadband last mile, noting that the first third threshold has been met to receive \$150,000.00 in grant funds from MBI. He said that 77 of 200 customers have been upgraded so far.

Young ended by saying that Board Chair Pruyne signed documents last week for a Town Forest acquisition project involving seventy-seven acres of the Victoria Shaw land between Shaw Road and the Town Forest. He said the grant is being administered by DCR.

- 8. Wendell Road McKnight Property—Young said that the 147-page preliminary report funded by a grant from FRCOG has been received by the Selectboard, Board of Health and Planning Board. He said that the report notes a significant amount of historic evidence of problems on site and recommends several test wells be dug to test the level of pollution/contamination to the ground water.
- **9.** Seaboard/Nautilus Solar Project—Young said that the smaller, 40-acre project adjacent to ours is being hosted by the Town of Ware, and that it is creating electricity. He said that our royalty payments will begin to accrue once the meter is installed.
- 10. Selectboard Reports—None this meeting.

- **12. Public Comment**—Fire Chief Gates said that the rescue vehicle could be declared surplus property. Police Chief Shoemaker said that it could be used for situational training and then be hauled away as junk, as it is no longer roadworthy.

Town of Warwick Selectboard July 3, 2017 Minutes

Members present: Dawn Magi, James Erviti, Lawrence Pruyne

Others present: Town Coordinator David Young, Town Secretary Rosa Fratangelo, Assessor's Clerk Beth Gilgun, Finance Committee member Steve Ruggiero, Ashley Arseneau (*Athol Daily News*)

I. Call to Order

Chair Pruyne called the meeting to order at 6:01 p.m. in the Town Hall.

II. Minutes

Magi MOVED to approve the minutes of June 14, 2017 and June 26, 2017 as printed. Erviti SECONDED. Motion CARRIED 3-0-0.

III.Presentations and Discussions

- 1. Community Compact Grant Application Young said that the grant application would be for the purposes of hiring an outside consultant to review PVRSD options. He noted that he has yet to see a scope of service, and that the pre-application process was likely done online. Chair Pruyne has not been asked to sign any documents.
- 2. Surplus Property Declaration Young explained that the Fire Department's rescue vehicle needed to be declared surplus property. He noted that Chief Shoemaker has expressed an interest in using the Tahoe for situational training before likely having it scrapped. Finance Committee member Steve Ruggiero suggested offering any good parts for sale prior to scrapping the vehicle.

Magi MOVED to declare the Tahoe rescue vehicle from the Fire Department surplus property to be used for the Town's needs. Pruyne SECONDED. Motion CARRIED 3-0-0.

3. Wendell Road McKnight Property —Young said that the preliminary report findings included the recommendation of further investigation into the potential environmental damage which would include the drilling of test wells. He said that there are questions of how much the actions would cost, who would pay those costs, and the legal issue of whether the Town can

drill on private property. Young explained that there is no clear ownership of the property as the deed is in the name of John A. McKnight, who died many years ago. Ruggiero cautioned the Board to be careful of the potential financial implications and liabilities. Young said we should wait for the final report, see what resources are available for follow-up, and investigate the legal implications the situation presents.

- **4. Review Year End Financials** —Expenditure and Revenue reports for the General Fund and Other Fuds were reviewed.
- 5. Selectboard Reports —Erviti said that he has noticed the cemetery is not being mowed well this year. Young said that he has received some complaints on that subject and has reached out to the Cemetery Commissioners to see what can be done to remedy the situation.

Pruyne said that he has submitted a proposal for a pesticide management and vegetation control policy to the Board of Health for its review. He wishes to have the use of the chemicals present in Round Up banned. Young noted that it is illegal to apply herbicide to the land of another, as herbicides may only be used on one's own land. He said that there was a vegetation control plan developed when Tim Kilhart was the Highway Superintendent. Young also noted that the Town Forest Committee is looking into hiring someone to apply herbicide to the Town Forest as a way to combat and control invasive species. Pruyne said that he will share his proposal with fellow Board members and the Town Coordinator.

- 6. Coordinator Report —Young said that the Highway Department will start setting the WBS poles on Monday, July 10th. He said that the Conservation Commission is holding a hearing the same day on the Town's intention to remove the Gale Road bridge superstructure.
- 7. **Public Comment**—Ruggiero said that we should take down the Gale Road bridge railing, go over the deck and be sure to get a fair price on it. Young said that he is discussing the project with engineer Jim Toth.
- 8. New and Other Business Unanticipated at Time of Meeting Posting —Assessor's Clerk Beth Gilgun said that the Board of Assessors will be changing its software supplier and get new software in FY 19. She had a contract that required the Board Chair's signature. Pruyne signed the document. Gilgun noted that the Selectboard had previously voted to approve the new software and authorize the Chair to sign the related documents at a previous meeting (November 7, 2016).

Town Clerk Rosa Fratangelo said that when she swore in Leanne Limoges for her FY 18 term on the Recreation Committee that Ms. Limoges asked that Shauna Lynn Mallet Smith be reappointed as well.

Erviti MOVED to appoint Shauna Lynn Mallet Smith to the Recreation Committee for FY 2018. Magi SECONDED. Motion CARRIED 3-0-0.

IV.Adjournment

At 6:40 p.m., Erviti MOVED to adjourn. Magi SECONDED. Motion CARRIED 3-0-0.
